# SUFFICIENCY ECONOMY PHILOSOPHY TOWARDS PERSONNEL LIVING OF LOCAL ADMINISTRATION ORGANIZATION IN EASTERN REGION IN THAILAND YEAR 2019

Abstract: Research on "Sufficiency Economy Philosophy towards Personnel Living of Local Administration Organization in Eastern Region of Thailand Year 2019" aimed 1) to study on the levels of sufficiency economy philosophy in the local administration organization in Eastern region of Thailand year 2019; 2) to study on the personnel living of the local administration organization in Eastern region of Thailand year 2019; 3) to study on the influences of the sufficiency economy philosophy on the personnel living in the local administration organization in Eastern region of Thailand year 2019; and 4) to study on the suggestions. The populations in this study were the personnel in the local administration organization in Eastern region of Thailand. Sample groups in this study were 400 of personnel in the local administration organization in Eastern region of Thailand. The convenience sampling method was adopted where the interviews and questionnaire were used as the research instruments. The statistics used for data analysis were frequency, percentage, average, standard deviation, correlation coefficient, and multiple regression. It was found by the study that most of the samples were single female aged between 25 – 34 years old. They graduated with Bachelor degree and monthly income between 10,001 - 20,000 baht per month. The sufficiency economy philosophy in the local administration organization in Eastern region of Thailand was found at the highest level. The highest score was on the aspect of morality, second by good self-immunity, rationality, knowledge and modesty, respectively. The levels of sufficiency economy philosophy towards the personnel living in the local administration organization in Eastern region of Thailand was found at high level. The highest score was on the aspect of social and culture, second by psychological, natural resources and environment, economic and technology, respectively. The influences of sufficiency economy philosophy towards the personnel living in the local administration organization in Eastern region of Thailand were on the aspect of morality, rationality, good self-immunity, and modesty. While in the aspect of knowledge, sufficiency economy philosophy showed no influence on the personnel living in the local administration organization in Eastern region of Thailand.

That is a philosophy that is beneficial to Thailand and many countries and support member countries to follow towards sustainable development. Ready to tolerate changes under globalization in a reasonable way, including the necessity of having a reasonable safeguarding system to have any effects resulting from both external and internal changes. This will require knowledge, prudence and extreme caution in applying various academic issues in planning and every step of the operation.

Decentralization is a word or something that people in Thai society are very interested and followed especially after the promulgation of the 1997 Constitution of the Kingdom of Thailand, it was one of the most clearly defined provisions regarding decentralization and local government. And as a consequence of the 2007 Constitution of the Kingdom of Thailand, making decentralization more clear in Chapter 14, Local Government Decentralization is therefore an issue that has received more attention respectively. And there is a link between self-government at the local or local level in Thailand.

Local government in the form of formal (Formal Institution), widely known as local government (Local Self Government) has a distinctive feature is the state certification which the certification may be written in the constitution law of the country or enacted in the law. 2. Moral conditions that must be strengthened consisting of with awareness of morality, honesty and have patience with diligence use intelligence in life. Guidelines / Expected results from applying the sufficiency economy philosophy to apply is a balanced and sustainable development ready to accept changes in all aspects, both economic environmental society knowledge and technology.

Quantitative research studies

Population and sample groups

For convenience, the researcher requests to collect data are personnel in the local government organization in the eastern region of Thailand, 400 people were selected by convenience sampling.

From Table 4.1, it is found that the sufficiency economy philosophy affects the lives of personnel in the local government organization in the eastern region of Thailand as a whole, namely morality (statistics at = 4.486, p = 0.000), rationality (statistics T = 3.700, P = 0.000) good immunity (Statistics T = 3.550, P = 0.000) and moderation (Statistics = 2.517, P = 0.012) and all 4 variables should be in the regression equation (Statistics F = 83.024K The p = 0.000), the primary philosophy of the 4 sides together can predict the lives of people in local government in the eastern part of the overall percentage of 51.3 (R2 = 0.513).

#### V. DISCUSSION

From the study, it is found that the sufficiency economy philosophy in the local government organization in the eastern region of Thailand is at the highest level. In terms of morality, having the highest score followed by in the aspect of having good self - immunity, reasoning, knowledge and moderation respectively, which the reason of this study is may be because the local government is a government agency which has always supported the use of the sufficiency economy policy in administration. There are also rules and regulations that make local government organizations must strictly adhere to especially the various fiscal regulations that disbursements must be transparent, verifiable, with clear evidence with the purpose of public benefit.

From the study, it is found that the level of the sufficiency economy philosophy has an influence on the life of the personnel in the local government organization in the eastern region of Thailand at a high level. In which society and culture have the highest scores followed by mental, natural and environmental resources, economy, and technology, respectively. The results of the study may be because the government agencies have been public relations about the philosophy of sufficiency economy for a long time and continue to do there has been an extension of the sufficiency economy philosophy in many contexts, such as the self-sufficiency economy philosophy for family, for agencies, communities, etc. People can apply the sufficiency economy philosophy at all levels.

From the study, it is found that the principles of the sufficiency economy philosophy influence the lives of personnel in the local administrative organizations in the eastern region of Thailand, namely morality, reasoning, good immunity and moderately. As for the philosophy of the sufficiency economy, knowledge does not influence the living of personnel in the local government organization in the eastern region of Thailand. If only knowing and not taking action not following the principles have no effect at all. Many people and many departments have good knowledge of the principles of Sufficiency Economy. But cannot do it because it focuses on self-indulgent consumption or in trend. Therefore, knowledge is not a factor that influences the lives of personnel in local government organizations in the eastern region of Thailand.
